The intensive cleaner and smoke resin remover, which works fast and independently can be used on hot and cold surfaces. Dissolves burnt on, charred and encrusted. Can also be used as an intensive grease remover in high dilution.

APPLICATION AREAS

Highly concentrated alkaline cleaner for alkali-resistant materials: grills, ovens, convection ovens, burnt-on food, charred food, and encrustations in pots, pans, etc. In case of heavy soiling, select longer application time. Regular use facilitates removal of residues. Check material compatibility in advance. We accept no liability for damage caused by improper use.

APPLICATION

Incrustations: Carefully apply cleaner undiluted, allow to act briefly and rinse off immediately with clear water. In the case of stubborn old incrustations, leave to act for longer and repeat the cleaning process as often as required repeat the cleaning process until all burnt-in residues have been removed.

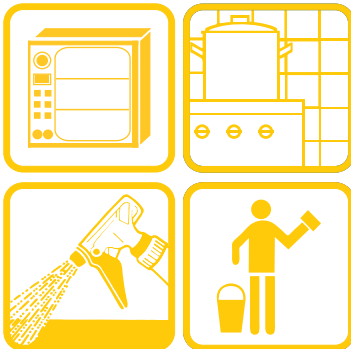
Grill cleaning: dilute 500 - 1000 ml with 10 liters of cold water.

Spray cleaning: dilute 1000 - 3000 ml with 10 liters of cold water.

Intensive grease solvent: dilute 100 ml with 10 liters of cold water.
